## CURRENT STATUS OF THE PROJECT

The feasibility analysis contemplates in pre-production a plant of up to 50 tons/day. In the exploration developed, 9 epithermal type targets have been identified, finding alterations that indicate the presence of Au, Cu, Mo in porphyry.

Environmental Impact Study filed No. 20223000053562 (02/28/2022) according to settlement filed 20213000010152 (01/13/2021). In ICANH Resolution No. 100 of June 2022, the Preventive Archaeology Program was approved. In July 2023 Resolution of Absence of Ethnic Minorities in the project was obtained.

### Main achievements in social management

As part of the project, we were able to manage the installation of an antenna that provides cellular telephone service in the area.

A daycare center and an animal slaughter facility were built.

The NMA is in the process of approving the first formalization project that will serve as a pilot project to integrate the traditional miners under title 20321.

PTO approved for small mining in the target named Los Azules up to 350 Ton/day: AUTO PAR-I No. 0087 February 24, 2014. Under review PTO for 5 more banks. Filed No. 20221001710362, 18/02/2022. Includes Social Management Plan (PGS).

**Additional project data:** The project is 100% owned by CMO Colombia S.A.S. It's located in Central Cordillera, in the Jurassic magmatic belt and covers an area of 2,634 hectares, at elevations between 1,400 and 2,200 meters above sea level, indicating a vertical continuity greater than 500 meters. With a high probability of the presence of a deep telescoped porphyry system. The identified mineralized area has an extension of 6 km by 4 km, the preliminary exploratory works indicate the existence of at least 6 porphyry-type exploration targets. Geological work suggests that three of the targets may have more than 2 million Oz Au and potential in the other epithermal targets; In addition:

- The contract area is not subject to any environmental restrictions.
- There are no ethnic communities present in the contract area.
