Adherence to initiatives and best practices:

Sustainability is a fundamental part of our strategy and is at the core of everything we do. Under this vision, we are conducting a detailed analysis to incorporate Environmental, Social and Corporate Governance (ESG) standards into our operation.

We are also in the first phase of implementing the globally recognized Towards Sustainable Mining (TSM) sustainability guidelines.

### Main achievements in social management

In 2021, the Social Management Plan was formulated in a participatory manner with the communities in the area. This plan benefited close to 3,800 people through the development of prioritized and jointly executed projects. This meant social investment, strengthening and training initiatives, all with the firm commitment to contribute to good community relations and wellbeing. Some of the initiatives that stand out are:

- Health: Improvement of infrastructure and equipment for the only Health Center in the area, which improved first-degree emergency care and contributed to the early detection of malaria.
- Education: Donation of materials for the adequacy of schools. Partnership management with the National Learning Service (SENA) for short- medium- and longterm training actions in free courses and rural entrepreneurship.
- Infrastructure: Improvement of rural roads, which reduced travel time by up to two hours. Community sewerage, provision of community spaces, delivery of a children's playground and soccer field.
- Community strengthening: Development of workshops to consolidate the Community Action Boards, recognizing their importance as an instance of government and leadership.

**Additional project data:** On May 31, 2022, the company announced the start of the feasibility study for the project, focused on updating the mine plan and the mineral resource estimate at the El Alacran deposit, in addition, a drilling campaign of 40,000 meters will be carried out, starting with 25,000 meters and six drill holes in the area of the El Alacran deposit in high grade mineralized areas.
